**BEING A BY-LAW TO AMEND BY-LAW 2008-008 BEING A BY-LAW TO PROVIDE
FOR THE REGULATION OF THE DISPLAY, SALE AND DISCHARGE OF
FIREWORKS IN
THE MUNICIPALITY OF MIDDLESEX CENTRE**

WHEREAS Council of the Municipality of Middlesex Centre enacted By-law 2008-008 on the 6th day of February, 2008 to provide for the regulation of the display, sale and discharge of fireworks in the Municipality of Middlesex Centre;

AND WHEREAS the Council of the Municipality of Middlesex Centre deems it desirable to amend By-law 2008-008 to add Schedule "2" to By-law 2008-008 - Short Form Wording and Set Fines in order to issue tickets under the Provincial Offences Act, R.S.O. 1990 c.P. 33;

NOW THEREFORE BE IT ENACTED THAT the Council of the Municipality of Middlesex Centre amend By-law 2008-008 as follows:

1. That Schedule "A" to this By-law entitled Schedule "2" to By-Law 2008-008 – Short Form Wording and Set Fines be added as Schedule "2" to By-Law 2008-008.
2. All other provisions of By-law Number 2008-008 remain in effect.

Read a FIRST, SECOND and THIRD TIME and FINALLY PASSED on this 1st day of April, 2009.
