# **Purpose and Effect of the Consent Application:**

The Municipality is seeking input on a development application that is located within 120 metres of your property. The purpose and effect of Consent Application B4/2023 is an amended request for Consent file B14/2022 to sever a lot from an existing single detached dwelling lot. The revised application seeks to sever a lot with a frontage of approximately 19.94 metres (65.4 feet) on Prince Street, and an area of approximately 671.7 square metres (0.165 acres). The retained residential lot would have a frontage of approximately 20.74 metres (68 feet) on Prince Street, and an area of approximately 709.8 square metres (0.175 acres). The effect would be to create a new residential lot for the purpose of establishing a single detached dwelling, and retain the existing dwelling on a separate lot.

The lands are designated Residential in Middlesex Centre's Official Plan and are zoned a Urban Residential First Density – Exception (UR1-4) Zone in Middlesex Centre's Comprehensive Zoning By-law.

### **Description and Location of Subject Land:**

The subject property is located on the east side of Prince Street, on the south east corner of the intersection at Prince Street and Duke Street in Komoka. The land is legally described as Lot 57 to 58, Plan 55, in the Township of Middlesex Centre, County of Middlesex, and is municipally known as 115 Prince Street.

The public meeting is an opportunity for members of the public to learn more about the proposed development via a brief presentation, ask questions, and/or make statements either in favour of, or in opposition to the proposal. #### Other Information

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting, or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 51(48.3) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
