# **Purpose and Effect of the Consent Application:**


The Municipality is seeking input on a development application that is located within 120 metres of your property. The purpose and effect of Consent Application B16/2023 is a request to establish a servicing easement for the purposes of a private sanitary main extension as a result of severance application B-4/2023. The effect would establish a 6.4 metre easement from Prince Street to the proposed lot being Parcel 3 of consent file B-4/2023.

The lands are designated Residential in Middlesex Centre's Official Plan and are zoned a Urban Residential First Density – Exception (UR1-4) Zone in Middlesex Centre's Comprehensive Zoning By-law.

# **Description and Location of Subject Land:**

The subject property is located on the east side of Prince Street, on the south east corner of the intersection at Prince Street and Duke Street in Komoka. The land is legally

described as Lot 57 to 58, Plan 55, in the Township of Middlesex Centre, County of Middlesex, and is municipally known as 115 Prince Street.

Please be aware that if you are submitting correspondence to the Municipality of Middlesex Centre regarding this application, your name, contact information, and communications may become party of the public record that will be available to the general public, pursuant to the Planning Act and the Municipal Freedom of Information and Protection and Privacy Act.
- 3) **SPEAK TO COUNCIL** remotely by pre-registering with the Planning Department by emailing <u>planning@middlesexcentre.ca</u>. Upon receipt of your email, you will receive a reply with instructions for obtaining your unique Zoom link in order to participate in the Public Meeting.
- 4) **ATTEND THE MEETING IN PERSON** at the Middlesex Centre Municipal Office. Any members of the public who wish to speak to an application will be given the opportunity to do so.

#### Other Information

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting, or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 51(48.3) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
